INFORMATIVE NOTE ABOUT PROCESSING AND PROTECTION OF PERSONAL DATA

1. Data processing controller and data protection manager

The Data Processing Controller is the Foundation for Financial Education and Savings (FEduF) with its registered office in Rome, address Piazza del Gesù, 49 (ZIP 00186).

2. Purpose and legal basis for processing

FEduF processes personal data for the following purposes:

A. Need to proceed with the scholarship for the project "I Fuoriclasse della scuola" ("the Project") which you asked to support with a cash contribution. The data are therefore necessary to manage your donation and the related fulfilments. This need represents the legal basis that legitimates the consequent processing. The provision of the necessary data for these purposes represents a necessary requirement for the receipt of your contribution. Without these, FEduF might be unable to proceed.

B. Need to fulfil legal obligations. This need represents the legal basis that legitimates the consequent processing. The provision of the necessary data for these purposes represents a legal obligation. Without these, FEduF might be unable to establish relationships and could be obliged to issue alerts.

C. Promotion of FEduF's institutional activity, including carrying out researches and in-depth analysis of the sector, as well as an update on FEduF's activities. The legal basis that legitimizes consequent processing is your consent, which you are free to give or not, and which you can always withdraw at any time. The provision of the necessary data for these purposes is not mandatory and refusing to provide them does not result in any negative consequence, except not being able to receive updates on FEduF's activities or participating in studies and analysis of FEduF itself.

3. Categories of processed data

FEduF processes personal data which are gathered directly from you, meaning from third parties which include, for example, biographical data, such as name, last name, address, date and place of birth, data related to the image, such as photos on documents or made during events organized by FEduF itself and video recordings, for example recordings of orders made over the phone and other data connected to the above mentioned categories.

FEduF could process special data to respond to specific requests of the Project participants. In such cases, FEduF will ask the interested person a special consent to process such data in order to follow up on these requests.

4. Recipients or categories of recipients of personal data

As persons authorized to process the personal data necessary to carry out the tasks assigned, the following persons belonging to these categories, could become acquainted with your data: FEduF employees, interns, consultants and employees of external companies called Managers.

The data can be communicated:

i) to those subjects to whom such information must be given in order to fulfil an obligation provided by the law, by the regulation or by the Community legislation;

ii) to the institutions participating in the Project;

The personal data acquired will never be disclosed, except for the publication of the list of supporters of the Project "The Fuoriclasse della scuola". The personal data acquired will never be transferred to third countries or international organizations outside the EU.

5. Rights of interested parties

5.1. The general Data Protection Regulation ("EU Regulation 679/2016") assigns specific rights to individuals, individual companies and/or freelancers ("Interested parties"), including the right to know which personal data are owned by FEduF and how these are used (Right of access), the right to receive updates, corrections or, if interested, the integration, as well as the cancellation, transformation into an anonymous form or the limitation.

The interested parties may at any time withdraw the consent, if issued, to process data with the purpose of sending promotional material.

FEduF points out that the withdrawal of the consent will have any effect only for the future.

5.2 FEduF processes and stores personal data for the whole duration of the Project, to carry out the relative and consequent obligations, to respect the applicable law and regulations, as well as for defensive purposes, either own or of third parties and until the end of the limitation period of the applicable law, starting from the end date of the Project.

At the end of the applicable retention period, the personal data referred to the interested parties will be deleted or stored in a way that does not allow the identification of the subjects involved (e.g. irreversible anonymization), unless their further processing is necessary for one or more of the following goals: i) resolution of pre-litigations and/or litigations started before the retention period expired; ii) following up on the investigations/inspections performed by external authorities; iii) following up on the requests of the Italian and/or foreign public authorities received/notified to FEduF before the end of the retention period.

5.3 Each interested party may ask to receive or request the transfer of his/her personal data owned by FEduF to a structured format, customary and available for other personal uses, which means to give them to another data controller (Right to portability). In particular, the data that can be subject to

portability are the personal data such as name, last name, title, date of birth, sex, place of birth, residence, etc.).

6. Procedure for the exercise of rights

The deadline for the reply is one (1) month, extendable by two (2) months for particularly complicated cases; in such cases, FEduF provides at least an interim reply within one (1) month.

The exercise of rights is in principle free; FEduF reserves the right to ask for a contribution in case of clearly unfounded or excessive (or even repetitive) requests.

FEduF has the right to request necessary information in order to identify the applicant.

7. Complaint or report to the Guarantor for the protection of personal data.

FEduF informs you that you have the right to make a complaint, meaning to report to the Guarantor for the Protection of personal data or to appeal to a Judicial Authority.
