PROCESSING AND PROTECTION OF PERSONAL DATA POLICY

1. *Data processor and responsible and data protection officer*

The data processor is the Foundation for Financial Education and Savings with registered office in Rome, Piazza del Gesù 49 (CAP00186).

2. *Purpose and legal basis of the processing*

FEduf process personal data for the following purposes:

- A. Need to implement the scholarship for the Project "I Fuoriclasse della Scuola" ("The Project") that you asked to support with a financial contribution. For this reason, the personal data is necessary to manage your donation and the related obligations, sometimes also of legal nature. This need represents the legal basis that legitimates the processing. To provide the data necessary to fulfil these aims represents a fundamental requirement upon receipt of your contribution; in lack of these, FEduf might be unable to implement the donation and to build relations with you.
- B. Promotion of the institutional activity of FEduf, including studies and researches in the sector, update of the activity of FEduf. The legal basis that legitimates the processing is your consensus, that you are free to give and that, at any time, you can revoke. It is not mandatory to provide the data necessary for these aims and the refusal to provide them will not determine any negative consequence, apart from the impossibility to receive updates about the activity of FEduf or to participate in the studies and in-depth analysis of FEduf.

3. *Categories of processed data*

FEduf processed the provided personal data directly to you, or collected or acquired through third parties, which includes, as an example, personal information (ex. name, surname, address, date and place of birth), image data (ex. document photos or photos taken in occasion of one of the events organized by FEduf) and video registrations (ex. telephone orders registrations) and other data related to the abovementioned categories.

FEduf might process particular data to implement specific requests of the participants to the Project. In these cases, FEduf will ask you a specific consensus on the possibility of processing particular data which are necessary to implement the request under discussion.

4. *Recipients or categories of recipients of the personal data*

The individuals who belong to the following categories can access to your personal data, in the capacity of authorized individuals to the processing of personal data, related to the data necessary for the performance of the assigned duties: employees of FEduf, interns, consultants and employees of outside companies nominated "Responsabili".

The data can be communicated:

- i) to those subjects who needs to be informed to fulfill an obligation imposed by law, a

- regulation or EU legislation.
- ii) to the institutional subjects that participate to the Project.

The collected personal data will never be subject to disclosure, except the publication of the list of supporters of the Project "I Fuoriclasse della Scuola". The collected personal data will not be transferred to third countries or extra-EU international organizations.

5. *Rights of the data subjects*

5.1 The European Regulation on the protection of personal data ("EU Regulation 679/2016") gives to natural people, sole traders and/or freelancers ("data subjects") specific rights, among which the one to know which are the personal data in the possession of FEduf and how it is used (right to access), to have updates, the rectification or, if interested, the integration, the cancellation, the transformation in anonymous form or the limitation.

The data subjects can revoke at any time, whereas they have given the consensus on the processing of the data for purposes of sending promotional material.

5.2 FEduf processes and preserves your personal data for the duration of the Project to fulfill the obligations related to it, to respect the applicable legal and regulatory obligations, and for its own defensive purposes or for third parties and until the expiry of the statute of limitation, starting from the closing date of the Project.

At the end of the retention period, the personal data of the data subjects will be cancelled or preserved in a way that will not allow the identification of the data subjects (ex. irreversible anonymization), unless a further processing is necessary for the one of the following purposes: i) the resolution of preliminary litigation and/or litigations started before the expiry of the retention period; ii) in follow-up to investigations/inspections started by external authorities before the expiry of the retention period; iii) in follow-up to requests of the Italian and/or foreign public authority notified to FEduf before the expiry of the retention period.

5.3 Each data subject can request to receive the processed of personal data related to him/her in the possession of FEduf in a structured format, of common use and readable for additional personal use or to provide them to the holder of processed data (right to portability). In particular, the data that can be subject of portability are the personal information (ex. name, surname, title, date of birth, sex, place of birth, residence, etc.).

6. *How to exercise the rights*

The deadline to a respond is of one month, extendable to two months in case of particular complexity; in these cases, FEduf gives a preliminary communication within one month.

The exercise of the rights is, in principle, free of charge; FEduf reserves the right to request a contribution in case of manifestly unfounded or excessive requests (also repetitive).

FEduf has the right to ask for information strictly related for the purpose of identification of the applicant.

7. Complaints or reports to the Personal Data Protection Authority

FEduf informs you that you have the right to complain or to report to the Personal Data Protection Authority or, alternately, to appeal to the judicial authority. The contact of the Personal Data Protection Authority is available on the website <http://www.garanteprivacy.it>.
